**CALL TO ORDER**

Chair Stupi called the hearing to order at 6:31 p.m. Notices were published and posted as required by law.

Stupi reported the first item for the meeting was for the electors to vote on the 2022 Town levy. Clerk Pedretti read the following into the record:

***RESOLUTION 2022-05***

***FOR ELECTORS TO ADOPT THE TOWN OF HOLLAND TAX LEVY***

***WHEREAS, Sec. 60.10(1)(a) of Wis. Statutes authorizes the Town electors of a Town to adopt the Town tax levy at a Town meeting of the electors; and***

***WHEREAS, a special Town meeting of the electors has been called and properly noticed to approve the 2022 total Town tax levy (to be collected in 2023), pursuant to Wis. Stat. Section 60.10(1)(a);***

***NOW THEREFORE, the special Town meeting of the Town of Holland, La Crosse County, Wisconsin, by a majority vote of the eligible electors duly assembled and voting on this 28<sup>th</sup> day of November, 2022, hereby resolves and orders as follows:***

***The Town Electors of the Town of Holland, La Crosse County, Wisconsin, hereby adopt the Town tax levy for 2022 (to be collected in 2023) in the amount of \$1,321,815.19 (including the approved levy of \$524,256, the approved fire safety referendum of \$582,500 and debt service payment of \$215,059.19).***

*The Town Clerk shall properly post this resolution as required by law under Sec. 60.80(1)(a) of Wis. Statutes within 30 days of the below noted adoption date. Adopted this 28<sup>th</sup> day of November, 2022, at a special meeting of the Town Electors.*

Motion by Herlitzke/Warzynski to adopt Resolution 2022-5. Motion carried 6 yeas, 0 nays, 0 abstentions.

Stupi reported the second item was discussion on board pay. No input given.

Motion by Weber/Herlitzke to adjourn. MOTION carried unanimously. Meeting adjourned at 6:34 p.m.
