- 13. Discussion/action Verify with Assessor that open book changes are included in the assessment roll
- 14. Allow taxpayers to examine assessment data

 - A. Waivers of the required 48 hour notice of intent to file an objection when there is good cause,
 - B. Requests for waiver of BOR hearing allowing the property owner an appeal directly to the circuit court,
 - C. Requests to testify by phone or submit a sworn written statement,
 - D. Subpoena requests, and/or
 - E. Act on any other legally allowed/required BOR matters
- 16. Review Notices of Intent to File Objection
- 17. Proceed to hear objections, if any and if proper notice/waivers given unless scheduled for another date
- 18. Consider/act on scheduling additional Board of Review dates(s) if necessary
- 19. Adjourn (to future date if necessary)
